IN CONSIDERATION of my involvement in the sport and activities under the auspices of U.S. Speedskating and Colorado Gold Speedskating Club, I acknowledge, appreciate, and agree that:

- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS; both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERS;

I, FOR MYSELF, AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES, and NEXT OF KIN, HEREBY RELEASE, HOLD HARMLESS, and PROMISE NOT TO SUE U.S. SPEEDSKATING, Colorado Gold Speedskating Club, World Arena, city of Colorado Springs, county of El Paso, THE INTERNATIONAL OLYMPIC COMMITTEE, THE UNITED STATES OLYMPIC COMMITTEE, THE INTERNATIONAL SKATING UNION OR OTHER SPONSORING ORGANZIATIONS, THEIR OFFICALS, VOLUNTEERS, STAFF, SPONSORSORS AND/OR AGENTS ("RELEASEES") WITH RESPECT TO ANY AND ALL INJURY AND LOSS ARISING FROM MY PARTICIPATION, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIENCE OR WANTON MISCONDUCT.
